The past or ongoing Initiatives were discussed:

- General
  - Board Nominations: Still recruiting, please have all nomination in by the end of the month.
  - St. Marys Tabby Trail: Will connect Cumberland Island Welcome Center to Crooked River State park. Collaborative is assisting with needed demographic information for the TIGER Grant.
  - Town Hall for the child: United way is moving from a strict allocation model to a model that focuses on the first 7 years of a child's life. This event is in the planning stages.
  - Putt & Play Miniature Golf Project: Working with PSA to open the miniature golf course.
- Alcohol Prevention Project:
